Enclosed please find the documentation in support of Administrative Modification #13 to the SJCOG 2009 Federal Transportation Improvement Program (FTIP). The SJCOG Executive Director has the authority to approve all administrative modifications. State approval is required; however Federal approval is not required.

The proposed modification is consistent with the 2007 Regional Transportation Plan as well as with the public participation plan adopted by the SJCOG board as amended. Proposed modification will affect delivery of the ARRA funds; SJCOG requests an expedited review and approval of this modification.

FTIP Administrative Modification #13 amends the following project in the 2009 FTIP:

(1) City of Ripon, Main Street Roundabout (CTIPS ID# 212-0000-0488)

Modify Project description to add parking required as mitigation to replace existing parking that will be eliminated due to design of the Roundabout.
