


CENSUS DATA FOR SAN JOAQUIN

- San Joaquin County was one of the original counties at the time of California's acceptance into the Union in 1850.
- The county was named after the San Joaquin River, which runs through the county.

LOCATION

- San Joaquin County is located in northern California, seventy-five miles east of San Francisco, fifty miles south of Sacramento, and seventy-five miles from the Sierra Nevada Mountains.
- It consists of eight cities: Escalon, Lathrop, Lodi, Manteca, Mountain House, Ripon, Stockton, and Tracy. San Joaquin County offers some of the finest opportunities in the state in boating, fishing, camping, history-gathering, or just plain fun in the sun. Each city, as well as the unincorporated county areas, offers a unique opportunity to enjoy California's beauty, nature, music, arts, and culture.
- The City of Stockton is the county seat.

LAND SIZE AND ENVIRONMENT

- The County size is 1,392.2 square miles or approximately 891,008 acres. ^[1]
- 2.5% of the county is occupied by water. ^[2]

AGRICULTURE

- The County remains one of the largest agricultural producing counties in California, with a total gross value of agricultural production at \$3,220,324,000 (2023). This reflects a 0.75% decrease from 2022.

- Agricultural production from the top five commodities (milk, grapes, almonds, cherries, eggs & poultry) totaled approximately \$1.87 billion.
- In 2023, milk remained the #1 agricultural commodity in San Joaquin County with a total value of \$633,384,000, a 1.1% increase from 2022. Grapes remained the second highest with a value of \$482,248,000, a 14.5% increase. Almonds saw a decrease of 25.2%, dropping to \$336,090,000. Cherries increased by 74.9%, reaching \$305,364,000. Eggs increased by 25.7% to \$181,157,000.
- Other commodity groups that saw notable changes include nursery products, which increased by 12.5%; apiary products, which rose 29.9%; and vegetables, including garlic, peppers, and tomatoes, which experienced varied growth. Livestock and poultry decreased by 12.6%, while field crops, such as wheat and alfalfa, remained relatively stable.
